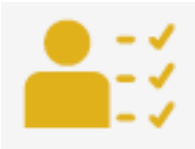

Commitment to the Prevention of CSEC In compliance with Law 679 of 2001 and Resolution 3840 of 2009, GOLDTOUR., It adopts the code of conduct in order to protect minors from sexual exploitation. In order to comply with the above, we have defined the following guidelines.

We will promptly inform the local police and / or competent authorities, the cases of sexual commerce with minors that are perceived or detected and the suppliers that develop practices related to this aspect.

Commercialize our products without deceptive advertising and without involving undue practices with children or adolescents.

Raise awareness and disseminate to the public that the sexual exploitation of minors is a crime.
